WITHDRAWAL POLICY: If your child/ren should withdraw before the start of the school year, a portion of tuition, not to exceed 80% of the total amount of tuition may be refunded; withdrawal by November 30th no more than 50%. All refunds are subject to School Administration approval. **After November 30th there will be no refunds on tuition for withdrawal of your child/ren.** In the event of an early departure, any outstanding tuition due will be due and payable. The \$200.00 registration fee and/or any late fees are non-refundable.
