\_\_\_ **OPTION 1 - PREPAID TUITION due June 1<sup>st</sup>**; A \$5.00 administration fee will be assessed by FACTS

\_\_\_ **OPTION 2 - FACTS 2 EQUAL PAYMENT PLAN (June 1 and January 1)**

Enrollment with FACTS must be completed by May 1, for payments to begin in June. Late enrollment will result in paying monthly payments. **A \$15 administrative fee will be assessed by FACTS for the second payment.**

\_\_ **OPTION 3 - FACTS 10 MONTH PAYMENT PLAN (June – March)**

Enrollment with FACTS must be completed by May 1, for payments to begin in June. Late enrollment will result in paying monthly balances already scheduled. All tuition payments made through FACTS end in March. **A \$50 administrative fee will be assessed by FACTS for families choosing this option.**

I/We, the undersigned, agree to pay the non-refundable **\$200.00 registration fee per student** and tuition amount above, less subsidy, scholarship, or financial aid, if applicable beginning in June according to the options above. If the **registration fee for returning students is not paid on or before December 30, 2022, space will be offered to families on the waitlist beginning January 3, 2023.**  
*I/We understand registration will not be accepted if current year tuition balances have not been paid in full.*

**WITHDRAWAL POLICY:** All parents who enroll students at St. Brigid agree to be responsible for 50% of their net tuition (after financial aid and scholarships if applicable) beginning June 1 until the first day of school, 80% from the first day of school to October 31st and 100% on November 1st to the end of the school year. Exceptions are made at the sole discretion of the Principal.
